"Since 2013, the 'Still I Rise Foundation' has provided a free counselling service to over 2,500 people living with cancer. One hundred percent of the funds go to the Counsellors providing these services to those affected by cancer," said Daniel.

All members of the Foundation act in a voluntary capacity with only the Counsellors in the hospitals delivering counselling services receiving payment.

Adrian Keys of Melrose Keys Lawyers said, "In addition to the local schools which we support throughout the year, we also support the Foundation. There are many fantastic groups who do incredible work, however this one is close to our hearts and touches everyone in one way or another. That is why we have decided to get behind the 'Still I Rise Foundation'.
